## Minutes of the American Association of Bovine Practitioners

## **Annual Business Luncheon**

Saturday, September 26, 2020 Kentucky Expo Convention Center Louisville, Kentucky

The meeting was called to order by AABP President, Dr. Calvin Booker, at 12:10 p.m. Dr. Booker presented the minutes of the St. Louis business meeting. On motion with a second, the minutes of the 2019 Annual Business Meeting were approved.

President Booker introduced the current AABP Executive Committee, Dr. Fred Muller, chair of the AABP Foundation, Dr. Sandra Godden, incoming AABP Vice-President, and Dr. Fred Gingrich, AABP Executive Director. President Booker acknowledged the program committee for their outstanding work in creating the content for the 53<sup>rd</sup> AABP Virtual Conference. Dr. Booker recognized retiring directors Dr. Gerry Koenig, District X, and Dr. Eric Behlke, District XIII. The election results for the board of directors was announced. Dr. Paul Cook has been elected to his first term representing District X and Dr. Ryan Rademacher has been elected to his first term representing District XIII. Dr. Elizabeth Brock was elected to serve her first full term representing District I. The following directors were elected to serve a second term:

Dr. Mark Hardesty from District IV

Dr. Carl Meyer Jr. from District VII.

The following committee chairs who have completed their term of service were recognized and thanked by President Booker:

Dr. Pat Comyn – Genetics and Genomics Committee

Dr. Anita Varga – Beef Health Management Committee.

Dr. Brian Reed, AABP Treasurer, presented the treasurer's report to the membership. He reported that the CPA firm of Irwin Financial Associates, LLP, Ashland, Ohio, completed a satisfactory combined audit of AABP and the AABP Foundation for the fiscal year ending December 31, 2019. They found no material

weaknesses. During the fiscal year 2019, total revenues were \$2,788,388, against total expenses of \$2,582,020, leading to an increase in net assets of \$206,368 on a consolidated basis from December 31, 2018 until December 31, 2019. As of the end of 2019, total net assets were \$2,545,991, of which \$1,307,889 have donor restrictions associated with them (scholarships, grants, etc.) and \$1,238,102 without donor restrictions associated with them. Also, of note, the multiyear process of conversion of AABP from a 501c3 organization to a 501c6 organization was completed by the conclusion of the end of fiscal year 2019. On motion with second, the Treasurer's Report was approved.

AABP Executive Director, Dr. Fred Gingrich, presented his report to the membership on the conference. The in-person portion of the conference was canceled due to civil unrest in Louisville. The virtual conference totaled attendance is 979 which includes 264 students, 1 veterinary technician, and 149 members of the American Association of Small Ruminant Practitioners. A total of \$193,500 in scholarship funds was awarded to 31 students by the AABP Foundation at the conference.

Dr. Callie Willingham, representing the AABP Foundation Board, announced that the winners of the 2020 AABP Foundation Competitive Research Grants were Dr. Gerard Cramer from the University of Minnesota and Dr. Manuel Chamorro from Auburn University.

Dr. Booker introduced the Merck Mentor of the Year Award. Dr. Booker presented the award to Dr. Gordon Atkins.


