# 18th Annual Conference Buffalo, New York November 16-21

An AABP landmark! - on July 1, 1985 the Association had 5600 members, plus 1000 student members.

Another important landmark was a meeting in May when the AVMA invited representatives from all food animal practitioner groups and related groups to meet in Chicago for an AVMA Food Animal Task Force. AABP representatives were requested to present a position paper on the concerns of bovine practitioners. Among the list of 15 major concerns were:

- 1. Availability of bulk drugs to veterinarians
- 2. Government harassment of bovine practitioners.
- 3. Federal fee basis
- 4. Liability insurance rates
- 5. AABP relationship with AVMA
- 6. Cost benefit ratio of services offered by bovine practitioners
- 7. The limited numbers of approved drugs available to bovine practitioners.

The 18th Annual Convention opened on a very cordial note when representatives of the New York State Veterinary Medical Society hosted a reception and dinner for AABP officers, the Board of Directors and their spouses on Monday evening, November 18 at The Hyatt Regency Hotel. Dr. Francis Fox, the guest speaker, kept his audience well entertained in his own inimical style. Each guest was presented a cup and cap bearing the Society's centennial logo. Dr. Harold Amstutz received a buffalo memento in appreciation of his long and dedicated service to the AABP.

At the Convention Opening Ceremony in the Buffalo Convention Center, the mood for an outstanding meeting was set by the Caledonia Pipe Band of Buffalo as they made their grand entry followed by the Honorable James Griffin, Major of the City of Buffalo and local arrangements chairman, Dr. Kenneth Benson. The Mayor gave the large audience a warm welcome to Buffalo "the Queen City" where the weather also cooperated throughout the week!

Eleven Technical Seminars were presented Pre-Convention with some emphasis now shifting to animal environment and health, embryo transfer and "total living" seminars.

#### Endnotes

Over 35 letters with 100+ signatures were received by Dr. Amstutz requesting the AABP to apply pressure on the AVMA and Federal Agencies to secure bulk drugs for veterinarians.

## **Beef Program**

Dr. Dee Griffin, Guymon, Oklahoma was the recipient of the Beef Program Award.

Dr. Griffin received the D.V.M. degree from Oklahoma State University in 1975 and the M.S. degree from Purdue University in 1978.

Dr. Griffin's positive attitude about veterinary medicine, coupled with his innovative approaches to preventive medicine have resulted in a successful and cost-effective health program for the 350,000 head of cattle under his supervision. Dr. Griffin assigned \$750 of the Scholarship to Oklahoma State University and \$750 to Purdue University.

#### **Dairy Program**

#### Dr. Lester L. Larson, Veterinary Department, American Breeders Service, DeForest, Wisconsin, received the Dairy Program Award.

A native of Amherst Junction, Wisconsin, he received the D.V.M. degree in 1953, the M.S. degree in 1954 and the Ph.D. degree in 1957 from the University of Minnesota. Dr. Larson is a Charter Diplomate, American College of Theriogenologists and became Head, Veterinary Department, American Breeders Service in 1974.
